Instructions

- If there are more than one vehicles or trailer in the trust, an original Certification of Trust must be required for each.
- Certification of Trust need not contain the dispositive terms of the trust.
- Recipient of this Certification of Trust may require the trustee to furnish copies of those excerpts from the original trust instrument and later amendments which designate the trustee and confer upon the trustee the power to act in the pending transaction.
- A person who acts in reliance upon this Certification of Trust without knowledge that the representations contained herein are incorrect is not liable to any person for so acting and may assume without inquiry the existence of the facts contained in this certification. Knowledge of the terms of the trust may not be inferred solely from the fact that a copy of all or part of the trust instrument is held by the person relying upon the certification.
- A person who in good faith enters into a transaction in reliance upon this Certification of Trust may enforce the transaction against the trust property as if the representation contained in this certification were correct.
- A person making a demand for the trust instrument in addition to a Certification of Trust or excerpts is liable for damages if the court determines that the person did not act in good faith in demanding the trust instrument.
- This does not limit the right of a person to obtain a copy of the trust instrument in a judicial proceeding concerning the trust.
- The applicant may modify the Name of the Trust to: a) fit within a 66 character and space limit and/or, b) to retain the registration expiration period of the individual's surname appearing in the name of the trust. The Division of Vehicles recommends the applicant keep a copy of the completed TR-81 form for future reference relating to the naming convention. The applicant should not place trustee information or "in care of"

- It is the responsibility of the person exercising this certificate to understand the requirements of KSA 58a-1013 as presented herein and how they relate to the trust instrument. Any questions concerning completing this certificate should be directed to your attorney.
